#### **RE: PGL Residential Trip to France 2023**

#### <u>Château de Grande Romaine – Our accommodation</u>

Just 20 miles from Paris, the beautiful Château de Grande Romaine is a great location if you are looking to explore France and experience the sights and sounds of its capital.

Whether it's a trip to the local market, the top of the Eiffel Tower, a boat cruise along the Seine or a visit to the theme park "Parc Astérix", it's a fantastic cultural adventure for your child.

And what better place to unwind after a busy day exploring than in the grounds of the Château de Grande Romaine. There are acres of space to relax in. There are also boules pitches, a cinema room, basketball courts and sports pitches.

The site is very secure and designed intentionally for large school trips of this nature.

Meals at Château de Grande Romaine are freshly prepared and designed to provide all the nutrition your child needs, including plenty of fresh fruit, vegetables and salads as well as plenty of carbohydrate for energy! PGL like to provide a balance between foods which are familiar and opportunities to try dishes with a distinctly French flavour too. There is always a vegetarian option available. PGL are familiar with most dietary requirements, so if your child has any allergies or a special diet for any reason, they will be catered for as long as we are aware. There are also vending machines and a small retail shop on site.



The centre was formerly a hotel and offers a good standard of accommodation for groups, with 4-7 bedded rooms with bunk beds and ensuite bathrooms. The Party Leader and accompanying adults will be roomed close to the children. All accommodation is adjacent to the main château building within the centre grounds.

#### The only additional cost will be pocket money, passport and meals en route.

The trip will be led by Mrs Cusimano in conjunction with PGL Travel Ltd, a first-class operator with a solid reputation for organising school trips - a reputation built up from over 60 years' experience in the school travel business. All PGL centres are regularly assessed by the relevant regulatory bodies within the industry and are operated to the highest standards. They are backed by ABTA membership and are ATOL licensed ensuring that all payments made are fully insured.

# Why take part in a residential visit abroad?

There are significant benefits to be had from a residential visit. It affords the opportunity for the pupils to succeed in a new challenge, enjoying the benefits of increased self-confidence and the forming of new relationships both within their peer group and the wider range of people they will meet whilst on the trip. It also offers a different cultural experience and the opportunity to develop a new awareness and sense of achievement. All students study GCSE French as a language and visiting the country will give them a greater understanding of the culture.

Please do note: We know that France has secular rules in place about the wearing of religious dress and items in public buildings or whilst undertaking public service as an employee of the government. This does not impact our students in any way. They can wear religious dress for all the activities we are participating in without any fear of discrimination for the entirety of the journey.

Mobile phones will be allowed on the trip, but use will be limited, and the school will not be responsible for any data or call charges. We shall be taking two school phones, enabling us to contact home if at all necessary and recommend pupils do not bring their personal devices. We will also be in regular contact with school and post updates via Twitter.

#### Information about paying for the trip

The total cost of the trip is £690

If you would like your child to take part in the trip, please detach, complete, and return the form below to the school office, together with a non-refundable initial deposit of £100 by 31<sup>st</sup> May 2022, payable on ParentPay.

## All pupils travelling to France require a valid passport (and visa if applicable).

We recommend that you organise your child's passport well in advance as it can take several months for passports to be issued, especially at peak holiday times.



All information you require is available on the Passport Office website.

- Full UK Passport Applications can now be <u>completed online</u>.
   It is also possible to obtain an application form from the Post Office, although this is a more expensive option.
- If your child has an EU passport, we will need the proof of settled status: <u>View and prove your immigration status GOV.UK (www.gov.uk)</u>
- If your child does not have a British or EU passport, you will need to apply for a visa (This will be an extra cost): Applying for a French visa in the United-Kingdom France in the UK (ambafrance.org)

# **Brexit**

Here is the latest Government advice on travel to Europe following the withdrawal of the UK from the European Union. New rules apply for travel to Europe as of 1 January 2021.

- You'll need to have at least 6 months left on an adult or child passport to travel to most countries in Europe (not including Ireland).
- If you renewed your current passport before the previous one expired, extra months may have been added to its expiry date. Any extra months on your passport over 10 years may not count towards the 6 months needed.
- You'll need to <u>renew your passport</u> before travelling if you do not have enough time left on your passport. However, all designs of British passports that meet the new rules will be equally acceptable for travel.
