- Preparing for meetings by reading reports and papers distributed in advance of the meetings
- Attending training to increase knowledge, skills, and ability to deliver duties and responsibilities
- Agreeing to the Code of Conduct for Members, Trustees and Governors
- Reading the Star Governance and Accountability Framework, and any relevant statutory information deemed essential and shared by the Governance Team
- Keeping informed on developments within the school
- Exhibiting knowledge on your specialism area to strategically help the direction of the school

## Nomination Form to become a Parent Governor

## Parents include:

- Natural or adoptive parents.
- Any individual who has 'parental responsibility' for or cares for a child at the school.
- A person with whom a child at the school lives and who looks after the child, irrespective of their relationship with the child, e.g., stepparent, grandparent, other relative or foster parent. However, the person must be involved in the full-time care of the child on a settled basis.

## To become a Parent Governor, nominees:

- Must not be a member of the Senior Leadership Team
- Must not be a supply teacher who is employed on a daily basis
- Must not be employed to work at the school for more than 500 academic hours per year
- Must have completed all relevant pre-employment checks, such as a valid
  Enhanced DBS Must not be subject to a Section 128 Barring Direction

A member of staff who is also the parent of a child at the school is not eligible to be a Parent Governor if they work for 500 hours or more in the school year. Note that if a Parent Governor subsequently starts to work at the school for more than 500 hours in a school year, they would serve out their term of office.

By completing this form, I confirm that I am willing to stand as a candidate for election as a Parent Governor and that I am not disqualified from holding office for any of the reasons set out above or under the School Regulations.
